

# **SCUC ISD Trailer Agreement**

## **TRAILER USE AND CHECKOUT PROCEDURES**

- ASTs have priority for use of trailers.
- Bumper pull livestock trailers may be used by parents or family members who assist the AST in transporting livestock.
- Trailers are used to haul only projects designated to show under Cibolo Creek FFA.
- Trailer alterations are not permitted.
- Individuals must:
  - Provide current driver's license to the Barn Manager
  - Provide current proof of insurance to the Barn Manager
  - Upon submission of driver's license and proof of insurance, a background check will be conducted.
- Guadalupe County Show, validation, state and national shows will take precedence over all other shows.
- Trailers will be blocked off for all validation periods and will not be available for checkout until the teacher has released the trailer(s).
- Trailer privileges may also be revoked by SCUC ISD administration and/or AST at their discretion.
- Any expenses due to accident or damage will be paid for by the person who checked out the trailer.
- The agriculture gooseneck trailer will only be used by ASTs.
- Trailer request must be submitted with barn manager 5 days prior to usage and must accompany animal leave paperwork. Trailers will be assigned once a completed form is turned in to the barn manager.
- Prior to usage, the barrower will conduct a pre-trip inspection of the trailer. Upon returning the trailer, the barn manager will conduct a post-trip inspection to assess any damages.
- After use of the trailer, student/parent is responsible for cleaning and washing out of the trailer.
  - Cleanliness of the trailer will be determined by the barn manager.
- Trailer must be returned to the same location of pick up.
- Out-of-state travel will be determined on a case-by-case basis

## **TOLL ROAD PRECAUTIONS**

- Trailers are not allowed on toll roads.

**BUMPER PULL TRAILERS/TRAVEL CAGES RELEASE OF CLAIMS AND WAIVER OF LIABILITY**

**Release of Claims and Waiver of Liability**

WHEREAS: SCUC ISD and Cibolo Creek FFA may choose to temporarily make available any or all tools and equipment owned by them under this agreement (specifically the “**Bumper Pull Trailers/Travel Cages**”) for use by the *Borrower* for a period of time ending \_\_\_\_\_, and for the sole purpose of transporting show animals. Bumper Pull and cages are only to be used to haul animals to stockshows, breeders, and processors only. They are not to be used for ANY type of personal use.

THEREFOR: I, *Borrower*, being of sound mind and capable of entering into this Agreement, and being aware of the risks involved in the use of the **Bumper Pull Trailers/Travel Cages**, do hereby give a FULL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS that I have, or may have in the future, against SCUC ISD, Cibolo Creek FFA and any related individuals or entities, for any loss, damage, injury or expense related to the use of the **Bumper Pull Trailers/Travel Cages**, even if arising from an automobile accident, and even if arising from negligence on the part of SCUC ISD, Cibolo Creek FFA or others associated with SCUC ISD or Cibolo Creek FFA. I further agree TO INDEMNIFY AND HOLD HARMLESS SCUC ISD and Cibolo Creek FFA from all expenses, fees, liability or damage award or cost of any kind whatsoever arising from the use of the **Bumper Pull Trailers/Travel Cages** by any person or entity during the time the **Bumper Pull Trailers/Travel Cages** are in my care and custody, including reasonable attorney’s fees in any lawsuit, claim or action. I further agree to follow all applicable laws and ordinances. I, *Borrower*, will be held liable for all financial responsibility while the equipment is in my possession. I further agree to conduct a safety check and make any necessary repairs on the **Bumper Pull Trailers/Travel Cages** before leaving the premises of SCUC ISD Toby Conner Ag Complex. SCUC ISD reserves the right to terminate the usage of SCUC ISD property.

**Release of Animal Liability**

*Borrower* hereby voluntarily releases and forever discharges SCUC ISD and Cibolo Creek FFA from any and all liabilities, claims, demands, actions, or rights of action, which are related to, rise out of, or are in any way connected with the transport of the aforementioned show animal(s). *Borrower* further agrees, promises and covenants not to sue, assert or otherwise maintain or assert any claims against SCUC ISD and Cibolo Creek FFA or their agents or employees, for any injury, death, disease, or damage to the aforementioned animal(s) arising from or in connection with the transport, care or feeding of said animal(s) or from any claims asserted by third parties.
